Golden Corral will contact you if your request has been granted. In an effort to assist our community, please understand that due to the overwhelming volume of requests that we receive, we regret that we are unable to fulfill all of them.

- **Golden Corral-Harlingen** agrees to donate the following FOOD items: Seasoned Chicken Leg Quarter, Mexican Rice, Ranch-style Beans, Bread, & Jalapeno; ice for ice chests. Golden Corral staff will prepare the side items and maintain hot items under appropriate hot holding temperatures per Health Department requirements.
  - **Golden Corral-Harlingen** agrees to donate the following DISPOSABLES: 3 compartment food boxes, plasticware, plastic bags
  - **Golden Corral-Harlingen** agrees to allow use of the: Parking lot premises with direct access from Tyler Ave., 1 BBQ Pit, charcoal, sanitation buckets, trash receptacles, food thermometer, & cooking utensils
  - **Golden Corral-Harlingen** agrees to assemble the plates within the kitchen and transfer plates to "Fundraiser's" volunteers.
  - **Golden Corral-Harlingen** agrees to assign a designated FOOD PROTECTION MANAGER to assist during the event.

- **FUNDRAISER** agrees to create, print, and sell tickets in advance of scheduled date. In the event of inclement weather, a rain date may be scheduled at the discretion of GC Management. Fundraiser must provide final plate count 7 days prior to the scheduled event.
  - **FUNDRAISER** agrees to: Advertise chicken plate sale and tag @GoldenCorralHarlingenTX in all social media postings.
  - **FUNDRAISER** agrees to provide: Additional BBQ pits/charcoal/lighter fluid, tables, tents, chairs, ice chests, bottled water, disposable food service gloves, hand sanitizer, Clorox disposable wipes, posters/signage, traffic cones, safety vests (for volunteers), money box with change for drive-up purchases, & walkie talkies. Fundraiser may include canned soda (at their own expense) with chicken plate.
  - **FUNDRAISER** agrees to: Arrive for set up promptly at **8:30am** and breakdown/clean up to begin immediately at **2pm**. All signage must be removed, and trash & charcoal disposed of properly in the appropriate receptacles at rear of building.
  - **FUNDRAISER** agrees to provide: Volunteers/manpower (recommended 6-8 per 100 plates sold) to include designated volunteers for cooking duties. Volunteers designated for cooking duties must be over the age of 18 and must be able to endure long periods of exposure to heat & smoke. *\*Please note that the "fundraiser" is responsible for the safety of the volunteers inside/outside of Golden Corral's premises. Volunteers must be at least 16 years of age & must be supervised by an adult at all times. Lonestar Corral, LLC-Silva dba Golden Corral-Harlingen will not be held liable for accidents or injuries occurring on location premises.*
