The following is general information of the terms and conditions for Golden Corral-Harlingen.

Minimum order of 20 people, unless otherwise indicated.

Includes paper plates, plastic ware, cups, & napkins.
PREMIUM disposable plates, plastic ware, cups, & napkins available for \$.95 per person.
China, silverware, & glassware available at an additional fee.

Delivery available with a 72 hour advanced notice.
Delivery is FREE of CHARGE within a 15 mile radius.
Further destinations will incur a \$25 Delivery Fee.

Full Service catering +20% gratuity (Plated /Table Service).
Buffet-style catering +15% gratuity (Buffet Service).
Chef Fees and Attendant Fees (where indicated) are separate charges.
All orders subject to 8.25% sales tax.

A deposit of 25% is required to secure catering services for parties of 50 or more and will be applied towards the balance due.
A final GUARANTEED NUMBER of Guests is required 96 hours prior to your event. This is the number upon which we will base your final bill.
Total due must be paid in full by the date of the event.
For your convenience we accept all major credit cards, cash, and business-issued checks.

Deposit becomes NON-REFUNDABLE if notice is shorter than 96 hours prior to the event.

Changes to catering order must be made with a 48 hours notice & requires management approval. We will make every effort to make accommodations to the changes but make no guarantee due to the short notice.

Golden Corral will not be held responsible for foods that are maintained out of food safety temperatures at events where Golden Corral personnel has not been contracted to serve.

We will bring enough food to ensure adequate servings. However, we will not be held responsible for food shortages due to "over-serving" in the event that Golden Corral personnel are not contracted to serve.
Due to state and local Health Department regulations, all un-served items will return with us.
